REGISTERING AN ORGANIZATION TO USE USDA GUS

If your organization has not been registered with USDA GUS, then you will need to register your organization using either of the methods below:

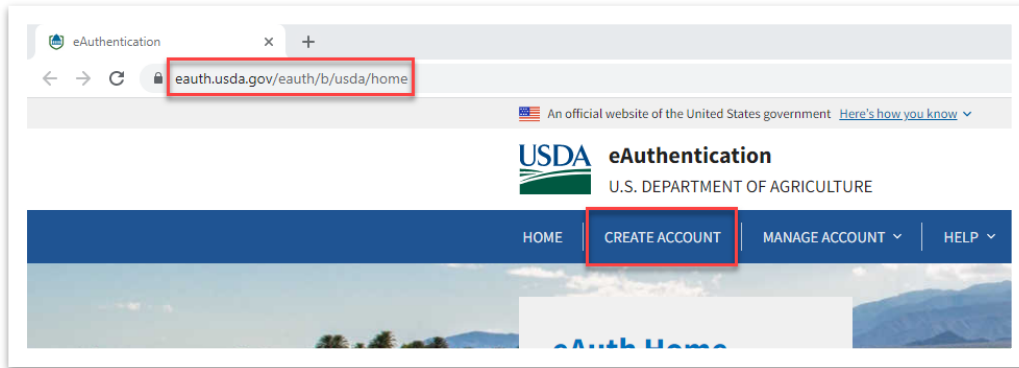

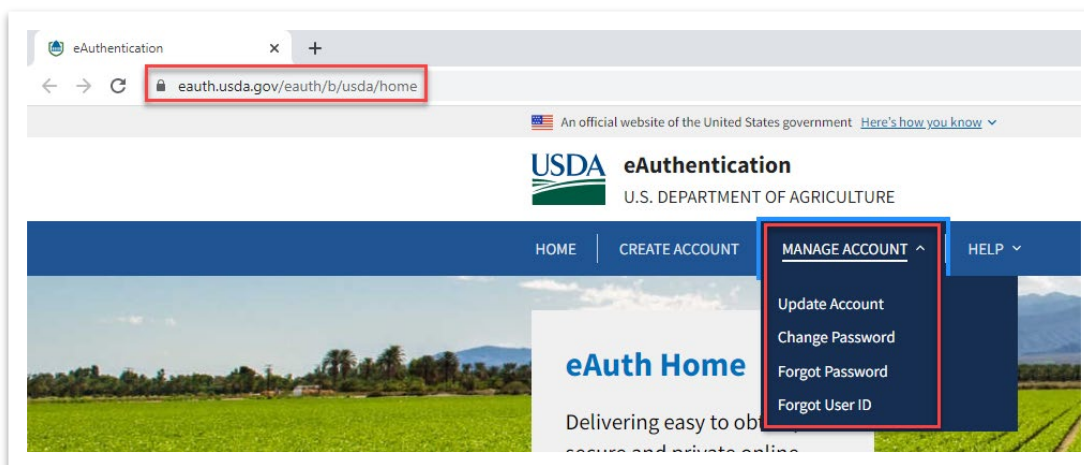
